Revise: 2.01 SHEET FLOORING as follows

2.01 SHEET FLOORING

- A. Provide Homogeneous Sheet Vinyl Flooring: ColorArt™ Medintone™ with Diamond 10[®] Coating manufactured by Armstrong Flooring Inc.
 - Description: An unbacked, nonlayered, homogeneous sheet vinyl flooring.
 Protected by a diamond-infused UV-cured polyurethane finish, the colors and pattern detail are dispersed uniformly throughout the thickness of the product.
 Color pigments are insoluble in water and resistant to cleaning agents and light.
 - Homogeneous sheet flooring shall conform to the requirements of ASTM F1913 Standard Specification for Vinyl Sheet Floor Covering Without Backing
 - 3. Pattern and Color: in color selected from the range currently available from Armstrong Flooring Inc.
 - 4. Width: 6 ft. 7 in. (2.0 m).
 - 5. Length: up to 65.6 lineal feet (20 meters)
 - 6. Thickness: 0.080 in. (2.0 mm)
- B. Vinyl Weld Rod:

Question: I am looking for floor finish confirmation on the following rooms: N9, N8, N4, N5 N13, N14,

L10, L11, L12, L13

Answer: Rooms L6, L7, L8, L9, L10, L11, L12, and L13 all have existing concrete floors and have no

work called out and are to be existing to remain. Rooms N4, N5, N8, N9, N13, and N14 all

have no work called out and are to be existing to remain.

Question: Fremont Millwork Co. is planning on bidding all new casework/countertops in lieu of

refurbishing of existing. All demo of existing would be by others. Please let me know if that

will be acceptable. Otherwise, we will have to pass on this project.

Answer: Replacement of existing casework that is noted to be refinished will be considered equal to

refinishing. Casework is to be to the same specifications as other new casework specified.

Question: Per spec section 102800 there is no grab bar model number being show. Do we have a

model number for this unit as they are shown as new on the plans?

Answer: B-5806 series. Lengths as noted on plans.

Question: On A3.52 Det #5 and Det #7 east wall is showing a paper towel dispenser. On Det #5 the

floor plan it is keynote#8, and on the elevation it is keynote #14. Which unit is this to be. If it is to be keynote #14 there is also no model number for this style of unit in the spec, and a model number will be needed for bidding. Also we have a similar issue at rooms L6 and L8.

Answer: Use keynote #14. Bobrick - 813061 or equal.
