SUMMARY:

Garden Coordinator for Grass Valley Charter School will plan for, collaborate and teach science/gardening classes to students in grades K-8. The Garden Coordinator will implement organic gardening practices and irrigation and have the ability to coordinate projects, solicit the aide of community volunteers, farm experts, and community experts and will also seek out local community resources to facilitate construction and maintenance of garden infrastructure.

ESSENTIAL FUNCTIONS:

Essential functions may include, but are not limited to the following:

- Maintain and develop the infrastructure of an organic school garden, including constructing a water science feature and pond, a toolshed, worm bins, garden paths, row beds, gathering areas, compost areas, orchard area, ground covers, border areas, and cooking/eating areas. Students and the parent community would be included in almost all aspects of planning and implementation of garden infrastructure creation.
- Plan for and teach science/gardening classes to students in grades K-8.
- Collaborate with classroom teachers in planning and coordination of schedules and in understanding individual and group student needs.
- Apply for grants to maintain garden funding
- Solicit community aide, network with community resources, and coordinate volunteers for garden projects.

PHYSICAL REQUIREMENTS:

- Applicants must be able to speak clearly, hear normal voice conversation, stand, walk, sit, kneel, crouch/squat, crawl, stand from a sitting position on floor, use a computer, use a telephone, work without guidance from supervisor, drive a vehicle.
- Reasonable accommodation may be made to enable a person with a disability to perform the essential functions of the job.

Primarily a garden and classroom setting in a public school environment.
