Welcome back to school and the Grass Valley School District Before and After School Program. The Grass Valley School District is offering **affordable** Kindergarten through 8<sup>th</sup> grade childcare at Bell Hill Academy, Scotten, and Lyman Gilmore Middle Schools.

Care is available at Bell Hill, Scotten and Lyman Gilmore Schools, Monday through Friday, 7:00 to 9:00 a.m. and from the release of school to 6:20 p.m. Lyman Gilmore and Scotten program hours will be until 6:30 p.m. We are happy to offer students supper, a healthy snack, homework assistance and fun recreational activities!

There are three types of care available in our school district:

- 1. Our **"Year-Round Program"** offers childcare with an income-based, need for care with FREE to a sliding scale fee. Care is available every weekday, all year round, except legal holidays. Enrollment is on a continuous basis.
- 2. Our "After School Education and Safety Program" (ASES) is affordable and is offered before and after school on regular school days. Enrollment is limited and offered on a first-come, first-served basis. See rates on back.

\*\*SPECIAL NOTE\*\*: All Programs start on the first day of school, August 15. Bell Hill Academy, Scotten and Lyman Gilmore students should turn in the purple enrollment form to the school office or the afterschool program room. You will be called when your child can begin.

3. Our **"Break Care," aka "Full Pay Option"** is available before school, professional development days, breaks and summer session. **See rates on back.** Please call the programs Enrollment Coordinator for more details at (530) 575-6948.

## ASES Policy Changes 2018 – 2019

The Grass Valley School District has been operating the After School Education and Safety program since 2007 with great success and partnership with our students, parents, school sites, district staff and community agencies. The costs of operating a quality program have risen since 2007 and to continue to keep pace with rising staff costs, professional development and program supplies, the district will be charging an affordable monthly fee. The monthly sliding-scale ASES fees are based on the children's lunch status shown below. A full year is nine monthly payments. (i.e., 2 children x \$30 free lunch status x 9 monthly payments = \$540 total cost). Monthly payments will be accepted at each school site.

### **Break Care Program**

#### Before school, professional development days, breaks, summer session

#### Registration fee: \$50.00 (Annual Fee)

**Contract rates:** (Program used on a regular basis – same days each week, at least one month in duration). Contracted rates are billed monthly, and absences are non-refundable.

\$6.00/day	Before School (opens at 7am)
\$32.00/day	Non-School Days (breaks, professional development days, summer)

**Drop-in rates:** (Program used on an irregular basis or less than 1 month). Fees are due when the child is dropped off at the program.

\$8.00/day	Before School
\$34.00/day	Non-School Days (breaks, professional development days, summer)
